# **History & Background Information**

On August 1st 2016 we launched the GMB National Life Long Learning Fund

This fund is available to members to help them access education.

The fund was launched to coincide with the first meeting of the GMB National lifelong Learning Committee which was created in line with Congress Motion 74 2015. Any member who meets the requirements can apply to it for financial assistance in pursuance of education and training.

This membership benefit is viewed as both an organizing tool and a retention tool.

As an organising tool for non-members of the GMB have to become members and have at least 53 weeks continuous subscriptions to apply.

As a retention tool it is aimed at members who may have recently lost their employment and need financial assistance to assist them to upskill and reskill.

#### **Terms and conditions**

GMB members can apply by completing a national Lifelong Learning fund application form for financial assistance towards any course that they have enrolled on, or would like to enroll on, to help them to achieve a qualification or skill which will enable them to improve their present & future employment and career opportunities.

Successful applicants cannot reapply to the fund for a period of 12 months from receiving their last grant from the fund.

# **Application Criteria**

- The applicant must have been a fully paid-up member, on either the full time, part time, Sick/Unemployed or any other type of membership rate for more than 53 weeks.
- Successful applicants will be expected to retain their membership throughout the whole process with regards to the funding received.

- Applications should be made prior to the commencement of a course of study or during the application stage when the individuals know they are eligible to undertake the course.
- You must attend a Branch Meeting and present the application form at your Branch Meeting or online meeting where sections of form need to be filled in and relevant signatures obtained electronic signatures will be accepted. This is also where you see if the Branch will assist in funding.
- Once the form has been completed this must be signed by your Regional Education Officer (REO)
- Regional Education Officer is to send completed application form in full to the Chair of the NLLLC below electronically
- No commitments should be entered into on the assumption that an award will be made.
- The awards do not apply to any other college, institution or training provided
- The member requesting funding may be invited to the Teams meeting to be interviewed by the Panel
- There is an appeal process which is stated on the form, any appeal must be sent to the Chair on the email below.
- Funding for Open University and Post Graduate courses will be reviewed on a case-by-case basis. If funding is granted this would not be guaranteed for subsequent years
